Description: Decision Support has added a new Data Warehouse table containing NetID data as assigned by the University. The NetID data can be used in combination with other Data Warehouse data, and all users will have access to this table. The new NetID table can be accessed via ODBC at T_NETID, and associated NetID objects have been added to the Business Objects universes listed above.

Description: Decision Support has added a new column and associated objects for Print Indicator. The Print Indicator data is sourced from the Banner table SSBSECT.PRINT_IND and indicates whether the corresponding course/CRN data can be printed or made visible by University units. A new PRINT_IND column is available in the T_SECT_BASE and T_RS_SECT_BASE tables; corresponding objects are available in the universes listed above.

Description: Decision Support has modified a universe join to ensure that only Current records are included for reports using Vendor Type Code data. A restriction for EDW.T_VEND_TYPE_CD_HIST.VEND_TYPE_CD_CUR_INFO_IND='Y' has been added to EDW.T_VEND_TYPE_CD_HIST and all its aliases in the EDW Purchase Order invoices universe.

3.2 Add Year-to-Date Objects to OL/GL Universe

These objects should always be used with a specified Fiscal Year and Fiscal Period for reporting purposes.

3.3 Add User ID Information to Transaction Data

Description: Decision Support has added User ID information to the OL and GL Transaction data available in the Ledgers OL/GL universe and corresponding EDW tables (T_OL_DETL, T_GL_DETL, and T_POST_TRAN). User ID data for these transactions is derived from the User ID data stored in the Banner table FOBPROF and is populated using corresponding NetID data available in the EDW T_NETID table. New universe objects are named OL Detail User ID and GL Detail User ID and are available in the Operating Ledger Detail and General Ledger Detail classes, respectively.

The User ID information will enable units to view which users are creating and applying transactions to specific CFOAP accounts. Using this new data, users can systematically identify transactions which were created by a particular User ID, in order to isolate high risk transactions based on user id, which could have been inappropriately charged to the college/dept C-FOAPAL.

Description: Decision Support has added Organization data to the Position History table (T_POSN_HIST) in order to enable users to more easily report on positions belonging to their organization. Users are now able to use this new data combination to easily identify open positions within an organization, among other reporting goals.

Organization Code data added to the Position History table is sourced from the Banner table NBRPTOT. All rows in the Position History table will be populated with the Current Organization Code data from the T_ORG_HIST table. Users who require historical organization code data can use the T_ORG_HIST table to view this data.

Description: Decision Support has corrected an error in processing logic on the T_CNTRCT_HIST table that incorrectly allowed more than one record to be marked with a Data Status Description of 'Current'. The processing logic has been corrected to ensure that only one row is marked as Current, and all other rows marked appropriately as Future, Expired, or Deleted.

5.4 Changes to Deduction Tables and Universe

Description: Decision Support has redesigned the structure of the Deduction/Benefits data in the Data Warehouse. The previous table and universe structures caused unreliable results for deductions associated with a deduction plan. The redesign of the Deductions data and universes will correct these errors and provide reliable reporting results for these types of deductions.

New tables to store Deduction data have been added, and the Deduction Administration universe has been altered to use the new data tables as the source for universe objects instead of the old data tables.

The new Deduction tables that have been added to the Data Warehouse are:

- T_BNFT_DED
- T BNFT DED HIST
- T_BNFT_DED_PLAN_AUD_HIST
- T_PERS_BNFT_DED_AUD_HIST
- T_PERS_BNFT_DED_PLAN_HIST

Action will be required.

Users who have created reports using the Deduction Administration universe should redevelop their reports as soon as possible to use the new objects available. Existing reports will continue to return results at least through the end of the year. However, Decision Support will eventually remove old objects from the Deduction Administration universe. Once these objects have been removed, any reports which use the old objects will no longer return results. Decision Support has not yet determined a data on which these objects will be removed.

Users who have created reports using an ODBC connection (i.e., MS Access, Crystal Reports, etc.) should redevelop their reports to use the new Deduction tables as soon as possible. Existing reports using the old Deduction tables will continue to return results at least through the end of the year. However, Decision Support will eventually remove these tables, and they will no longer be available for reporting purposes.

Any reports which use these old tables will no longer return results once these tables have been removed. Decision Support has not yet determined a date on which these tables will be removed.

Decision Support updated the processing logic to ensure that the telephone number column is populated with telephone data marked as 'Current' in the Banner source system and the EDW base tables, regardless of sequence number.
